Our Commitment to Your Privacy

Your privacy is important to us. iGlow Spa is committed to safeguarding your privacy online. Except as set forth in this Privacy Policy, we will never share your personal information with anyone for any reason without your explicit permission. Please read the following policy to understand how your information will be treated as you make full use of our many offerings. By using the iGlow Spa website, you consent to the policies and practices described in this Privacy Policy. We may change our Privacy Policy from time to time. If we do make changes, we will post those changes here so that you will always know what information we gather, how we might use it, and to whom we may disclose it. Information We Collect

Any information submitted by you will be used only to process orders and improve our products and services.

Under no circumstance will we rent, sell, or share any information provided by you to any third party without your permission. Our site uses a contact form for customers to request a booking or information. Contact information from the order forms is used to get in touch with you to confirm the booking or when necessary.

We may also gather certain information about your use of our site, such as what areas you visit and what services you access, and we may also collect information about your computer hardware and software. The Use of Cookies

"Cookies" are small text files that are used to store and sometimes track information about you. Cookies are not used to run programs and do not deliver viruses to your computer. Cookies are stored by your browser on your computer's hard drive. Most browsers automatically accept cookies, but you can configure your browser to decline all cookies. Alternatively, you may be able to modify your browser setting to notify you each time a cookie is tendered and permit you to accept or decline cookies on a case-by-case basis.
